

## Army's 12th Annual Lean Six Sigma Awards LEAP Forward to Recognize Excellence in CPI Initiatives



A dozen Army organizations that have exhibited superior Continuous Process Improvement (CPI) methodologies to transform business processes were recognized during the 12th Lean Six Sigma (LSS) Excellence Award Program (LEAP) ceremony.
